**Notification of the client – individual,
concluded the Contract on bank account an (or) bank deposit**

1. Hereby,

JSC “Jusan Bank”

name of the bank/branch of the non-resident-bank of the Republic of Kazakhstan

(hereinafter – the Bank) would like to inform you about its participation in the compulsory deposit insurance system in witness of which the Bank received the Certificate No.16 dd. April 02, 2021.

2. In accordance with the Law of the Republic of Kazakhstan “On compulsory deposit insurance, placed in the Second Tier Banks of the Republic of Kazakhstan” (hereinafter – the Law) Your deposit (deposition)¹ is the subject of compulsory deposit insurance.

In case of revoke of the license of the Bank for conducting all bank operations JSC “Kazakhstan Deposit Insurance Fund” (hereinafter – the KDIF) will start payment for insurance reimbursement for Your deposit (deposition) during 35 business days from the date of revoke of the license of the Bank for conducting all bank operations. Such payment will be made within maximum sum of the insurance reimbursement, set by the Law.

The KDIF’s notification about a start and procedure of payment for the insurance reimbursement, as well as on the banks-agencies that perform payment for the insurance reimbursement, period and places of payments will be published in mass media, as well as posted on the KDIF’s Internet-resource: www.kdif.kz.

3. In order to receive the insurance reimbursement you need **during one year from the date of start of payment for the insurance reimbursement** to submit the application form into:

the KDIF in e-form using e-portal of payments of the KDIF or web portal “e-gov”, or the bank-agent, selected from the bank-agent list in a paper form.

Payment for the insurance reimbursement is made not later than 5 business days from submitting by you the application form for payment of the insurance reimbursement with attachment of the confirmation documents. You may become acquainted with the application forms for payment of the insurance reimbursement and the confirmation document list on the KDIF’s Internet-resource: www.kdif.kz.

4. The KDIF’s notification on a date of the end of the period of payment for the insurance reimbursement will be published 30 business days prior to expiry of the payment period in mass media and on the KDIF’s Internet-resource, as well as at the description of the KDIF with additional methods of provision of the information.

5. If **during one year from the date of start of payment** You did not apply with the application form for receipt of the insurance reimbursement according to the established procedure, such an obligation will be recognized as Your consent for transfer by the KDIF of the sum of the insurance reimbursement unclaimed by you to your individual pension account for recordkeeping of the pension contributions, opened according to the procedure, stipulated for the legislation of the Republic of Kazakhstan on pension.

6. In case of failure to meet the deadline of payment for the insurance reimbursement by you, so you may submit to the KDIF a written application form for payment of the insurance reimbursement, and the KDIF will be able to pay you for the insurance reimbursement subject to presence of the valid reasons for such failure, stipulated for the Law. At that, such application form may be submitted before the end liquidation of the bank or before arising of the Bank's rights for pension payments owing to voluntary pension contributions as per the Law of the Republic of Kazakhstan "On pension in the Republic of Kazakhstan".
